# ENVIRONMENTAL POLICY

The purpose of the Henschke Environmental Policy is to define a vision for the future and to set environmental priorities and goals. The family business is committed to sustainability and will identify potential risks to our environment by implementing an Environmental Management System (EMS).

As a member of the Wine Industry's Environmental Code, EntWine, the Sustainable Australia Winegrowing (SAW) Program in the vineyards and ISO 14001 accreditation in the winery, Henschke is committed to achieving compliance and to ensure we safeguard and enhance the natural environment in which our business operates. As a signatory to the Australian Packaging Covenant Organisation (APCO) we will endeavour to comply with the principles of the APCO in relation to our packaging, waste and recycling. To guide these processes we will maintain an Environmental Action Plan and an APCO Action Plan, each reviewed annually, to cover current activities and initiatives.

### **Our Mission**

To create a diverse, integrated agricultural business which:

- Provides commercial benefit to the family stakeholders
- Protects, restores and sustains our environment
- Educates us all on the benefits provided by a healthy environment
- Uses organic/biodynamic production methods in the vineyards and over time all farm properties

#### Our Aim

To operate a profitable family business enterprise, utilising sustainable viticultural and farming practices within a healthy functioning ecosystem and produce premium quality products in sustainable packaging.

## Our Policy

- Sustainability: To integrate principles of sustainability to relevant business decisions in a cost efficient manner. These principles are:
  - Maintenance of long term productivity
  - Continual improvement from vineyard to customer through codes, covenants and EMS
  - Adopting suppliers with sustainable management
  - Increased efficiency in the use of natural resources such as soil and water, and waste minimisation
  - Awareness of biosecurity issues and adoption of preventative practices to maintain health and productivity of the vineyards, land holdings and business
  - Inter-generational and intra-generational equity (but not at the cost of business survival)
- Environment: To prevent pollution of our natural environment and build up soil health and biodiversity. We wish to maintain and restore 30% of our total landholdings with the original plant associations spread across the 5 different sub-catchments of the North Rhine, Parrot Hill, North Para, Upper Saunders and Onkaparinga:
  - riparian zones (within all five sub catchments)
  - native grasslands (1 in Upper Saunders Creek)
  - sheoak woodlands (2 in North Rhine and in Upper Saunders Creek)
  - peppermint box grassy woodlands (2 in North Rhine and in Parrot Hill Creek)
  - red gum grassy woodlands (1 in North Para River)
  - blue gum sclerophyll forest (2 in North Rhine and in Parrot Hill Creek, 2 in North Para River)
  - stringybark sclerophyll forest(1 in Onkaparinga)
- Community: Contribute to the quality of life in the 3 wine regions in which we operate and to form partnerships with community groups in the Adelaide Hills, Eden Valley and Barossa Valley.

Complying with this policy is a condition of employment with the company and it is the responsibility of all managers and supervisors to ensure the understanding, implementation and enforcement of this policy.
